INVESTMENT ANALYSIS

APRIL 30, 2023

The portfolio's value increased by \$323,000 (1.0%) during the month to a total of \$32,168,000. The net of fees performance of 1.2% for April was 40 basis points higher than the composite index.

For the year to date, the portfolio gained \$1,329,000 (4.3%) with a net return of 4.9% vs. 5.2% Composite Index return.

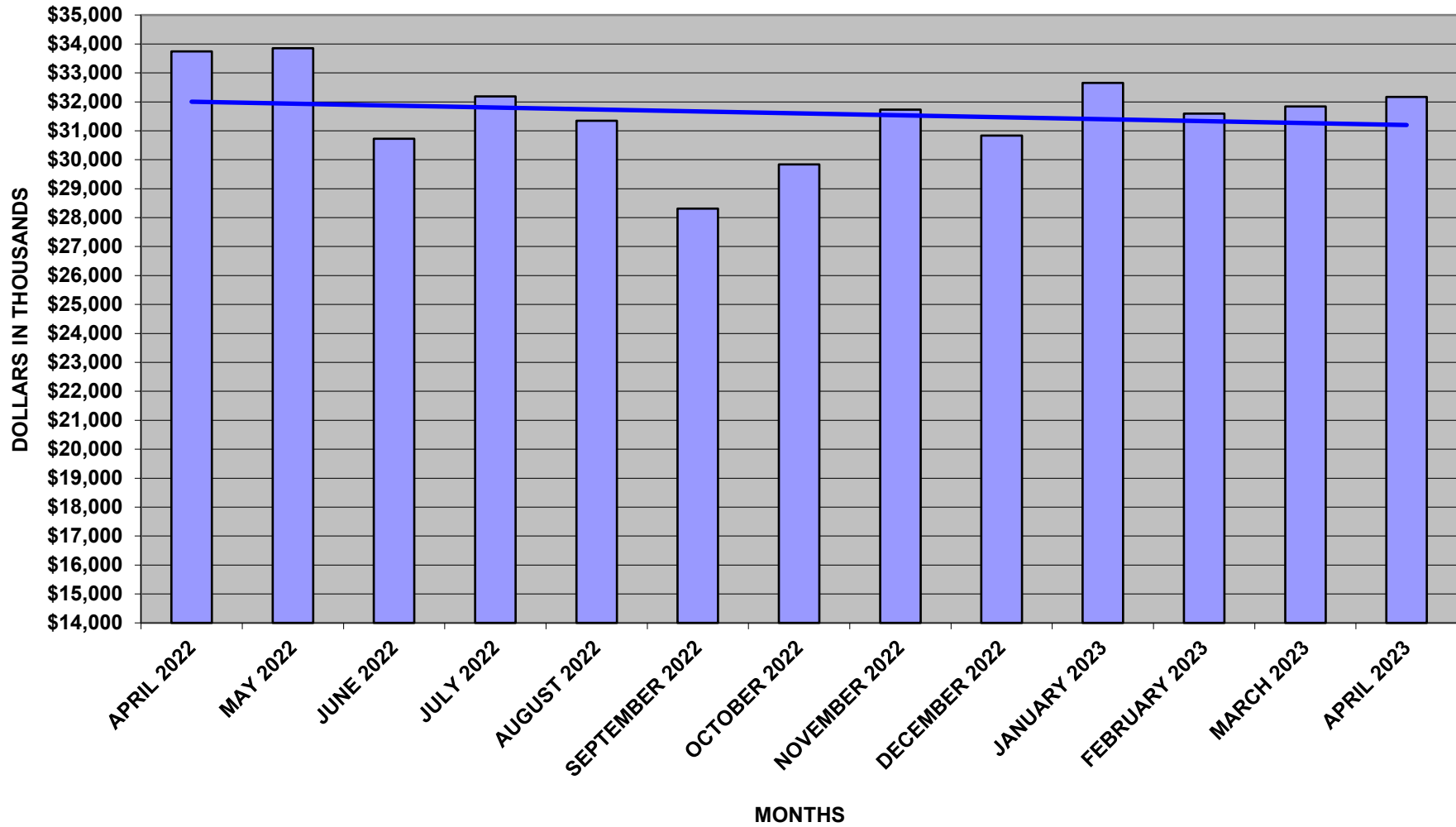

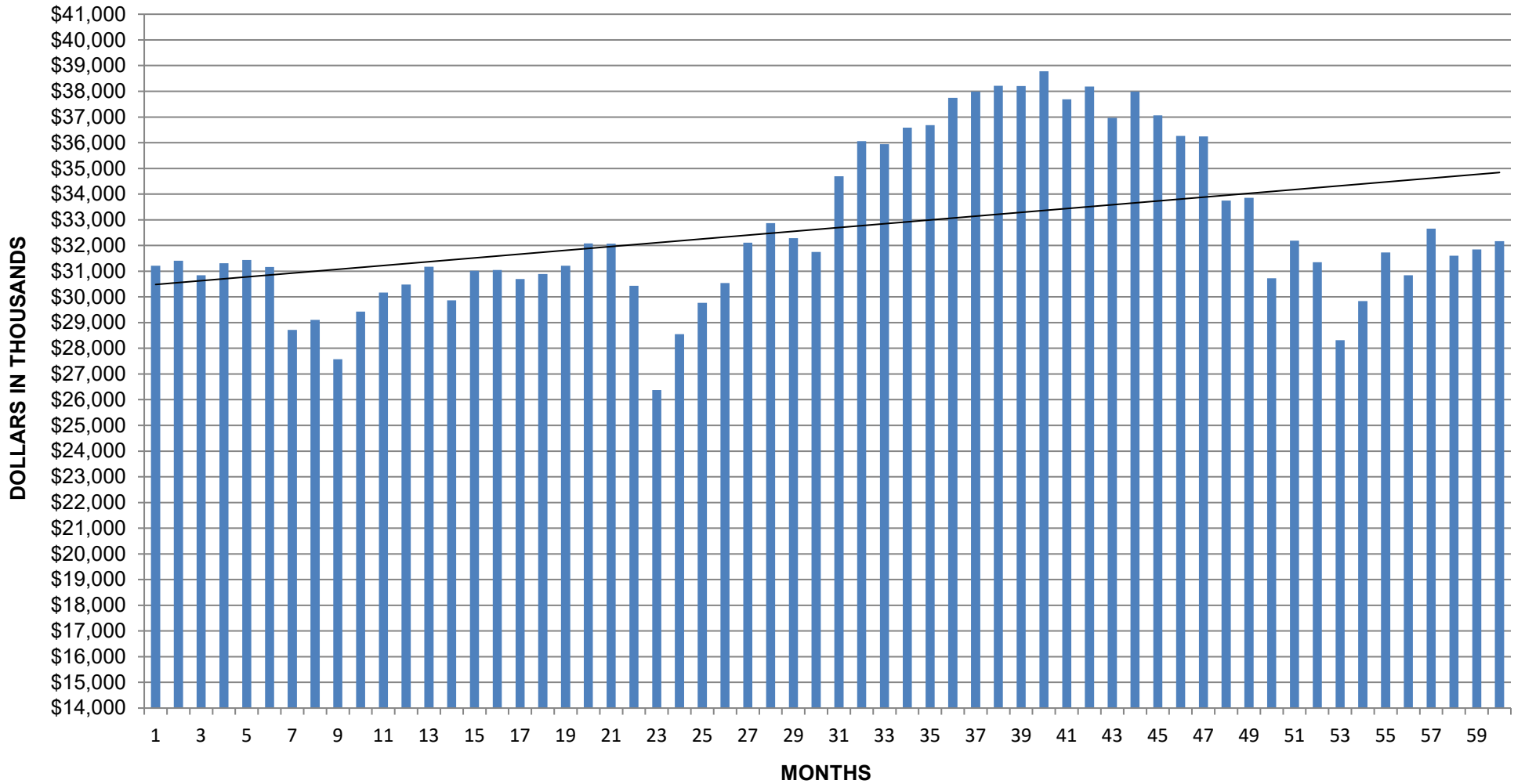

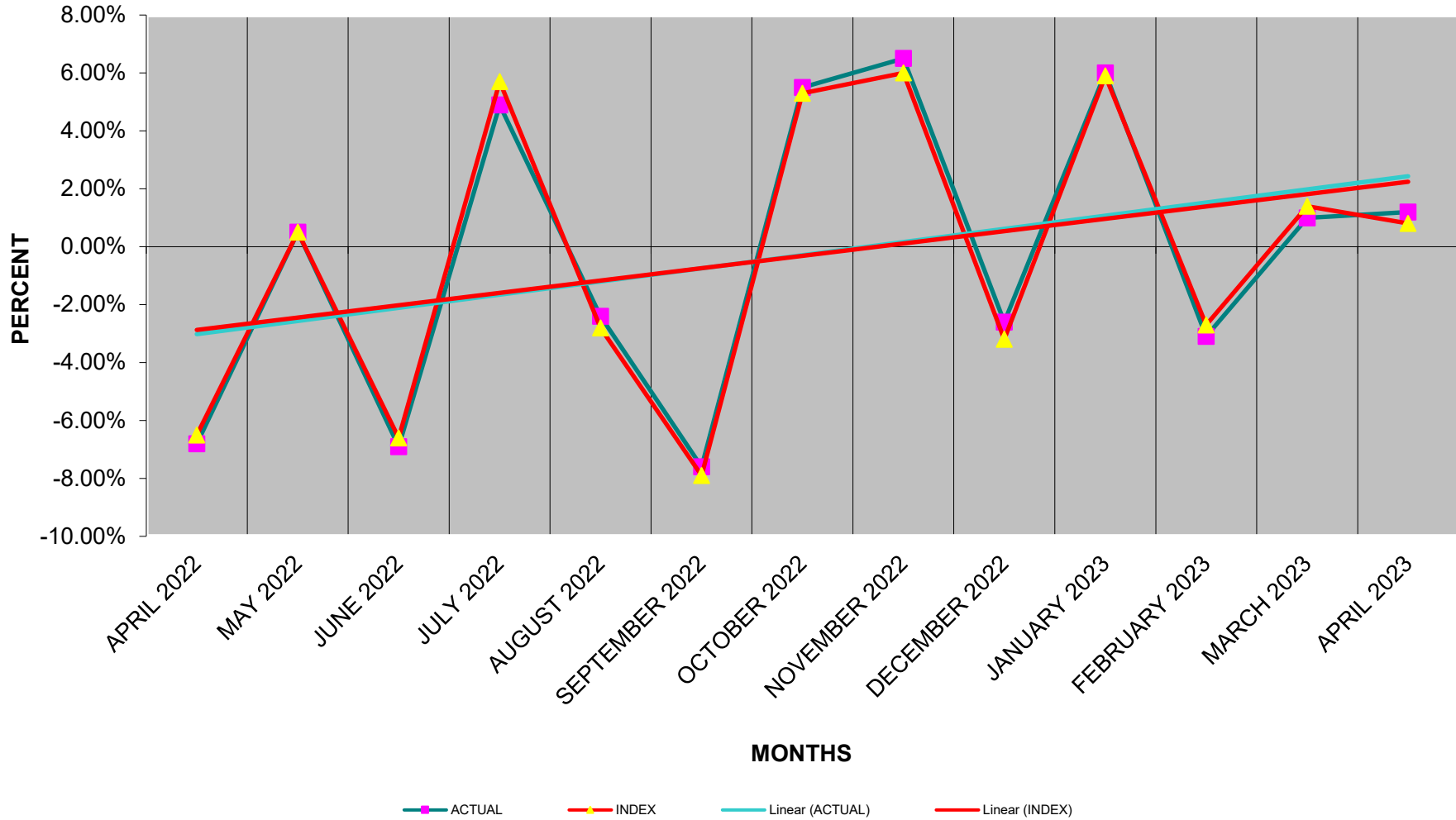
5 YEARS ENDING APRIL 30, 2023
