INTRODUCTION

UNITED STATES

- Economic data have consistently surprised to the downside the last few months, indicating macro momentum and inflation are slowing in the U.S. For example, the June ISM manufacturing and nonmanufacturing indexes both surprised to the downside falling below 49 (below 50 indicates contraction).
- Still, the profits cycle, massive fiscal stimulus and still-ample monetary liquidity remain supportive of economic growth and risk-assets in the near term.
- Low financial obligations relative to firm nominal personal income gains and rising net worth continues to support robust consumer spending for upper income cohorts. Lower income consumers appear vulnerable to a softer labor market.

GLOBAL

- U.S. growth appears to be slowing while the rest of the world is a mixed bag with Europe's recovery weak while China continues with deleveraging. Other emerging markets are benefitting from supply chain regionalization and security initiatives.
- The global manufacturing purchasing managers' index fell in June and remains slightly in expansion territory, suggesting global cyclical momentum is supportive but weak.

EMPLOYMENT, INFLATION & INTEREST RATES

- The labor market is "less tight" as there has been a clear softening in headline data. The unemployment rate rose to 4.1% in June, job growth is slowing, and job openings continue to decline.
- The Federal Reserve (Fed) is attempting to withdraw the liquidity punch bowl. If the extraction of excess liquidity leads to bouts of financial stress, the Fed can always reverse course and reinstate liquidity programs.
- Interest rate policy is linked to the path of disinflation which has picked up. Our base case is one or two rate cuts are possible this year if geopolitical-related supply side risk is contained.

DOLLAR & COMMODITIES

- Softer U.S. economic growth data have contributed to a softening in cyclical commodities. We believe global growth and commodity demand will remain muted, but geopolitical risk and geoeconomic maneuvering are wild cards for energy commodity prices.
- A few developed central banks are already cutting rates, keeping upward pressure on the dollar. But the relative U.S. growth advantage has faded. The Fed will eventually shift to an easier monetary policy stance on interest rates. Medium term, the U.S. dollar remains overvalued versus several currencies.

PROFITS

Margins are under pressure but remain relatively high as some companies net interest expenses are benefitting from higher rates. Top-line growth is holding up on massive stimulus that is supporting both real growth and inflation. Profits growth is narrow.

CIO PORTFOLIO STRATEGY AND ASSET ALLOCATION VIEWS

TACTICAL SHIFTS

February

- Raised Equities to slight overweight from neutral; funded the increase in Equities from exposure to areas of richness in Fixed Income; Increased Small-cap shares to slight overweight from neutral with a tilt toward value in this asset class; increased our exposure to cyclical Equity sectors

January

- Remained neutral both Equities and Fixed Income relative to our strategic targets while emphasizing a balanced approach to portfolio construction

MARKET VIEWS

- We expect volatility to remain elevated with choppy market trade as geopolitical risk remains at high levels and economic growth slows
- Equities are likely to remain range bound with a small upward bias into year-end as yields peak
- With a slower growth outlook and lower yields, corporate profits become the most important driver of returns in 2024

EQUITIES

- While the appreciation of the U.S. equity market has been disproportionately driven by a minority group of mega cap Growth stocks, we believe the rally may broaden over the coming months and quarters given a positive earnings outlook.
- We continue to incorporate cyclical exposure in our sector views by maintaining overweight allocations to areas like Energy, Consumer Discretionary and Industrials. Infrastructure-related investments and projects related to secular growth trends in electric power demand, energy transmission and distribution, cloud and data center builds and next-generation AI-focused semiconductor technology that is increasingly power hungry could drive multiyear demand for select cyclical stocks.
- Structural weaknesses in Europe from slower nominal GDP growth and less exposure to AI-driven expansion in the Technology sector remain persistent headwinds. And the recent rise in political uncertainty following the European Union parliamentary elections could further increase risk premiums due to investor concerns over fiscal policy, regulatory policy and higher credit risk, and their effect on interest rates and economic growth. China is likely to remain constrained by ongoing weakness in the real estate sector; meanwhile, India should continue to be supported by growth tailwinds from the digitization of the local economy.

FIXED INCOME

- We find the general valuation picture compelling in Fixed Income, particularly if economic weakness were to continue. We therefore reaffirm our view to be slightly long duration, which balances out these reasonable yields while near-term rate cuts are expected versus the risk of some positive economic uncertainty while inflation is still not at the Fed's target.
- We also reiterate our preference for rate risk over credit risk generally in Fixed Income, preferring Treasuries and Agency Mortgage-backed Securities (MBS).
- At current spread levels, forward excess Investment-grade returns have historically been negative; we therefore suggest staying up-in-quality until better opportunities present themselves.

ALTERNATIVE INVESTMENTS*

- While the environment remains broadly favorable for Private Credit, we see potential inflections for all three private asset classes coming into focus: spreads have tightened this year amid renewed competition from public leveraged credit markets and base rates are expected to decline contingent on Fed rate cuts.
- Meanwhile, Private Equity (PE) and Private Real Estate have been slogging through a multiyear adjustment period. Within PE, Buyout strategies have remained relatively resilient; however, Venture Capital and Growth Equity strategies have experienced sizable drawdowns.
- Broad-based central bank purchases have been key to gold's ascent however, we continue to believe gold is most effectively implemented as a strategic diversifier.

- Generate attractive cash flows across asset classes
- Active rebalancing during periods of outsized weakness and strength

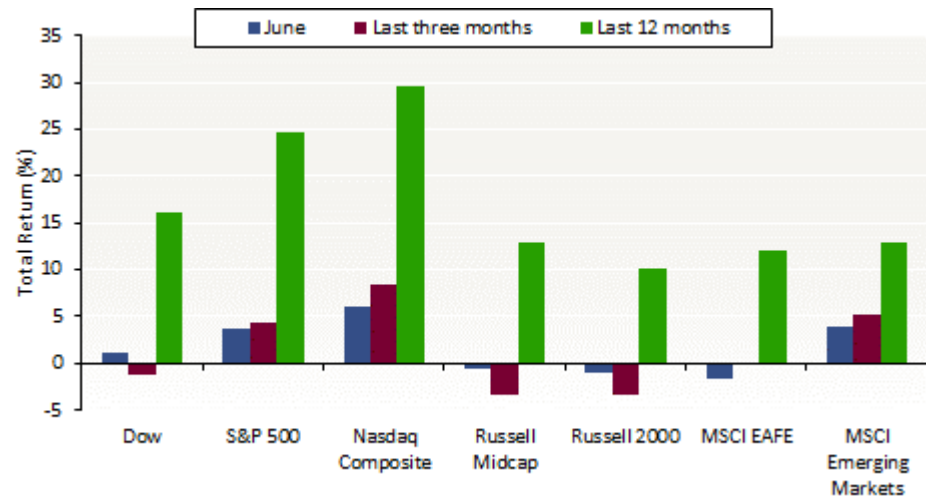

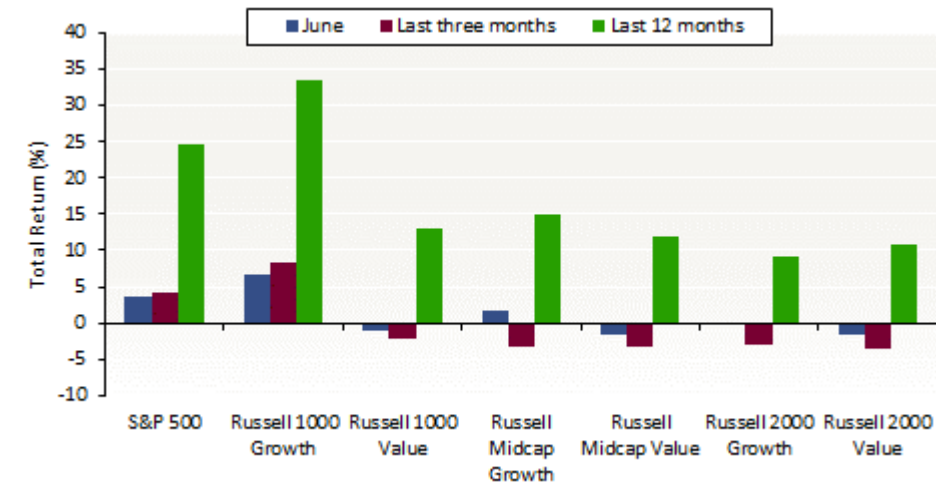


Equity Market Performance



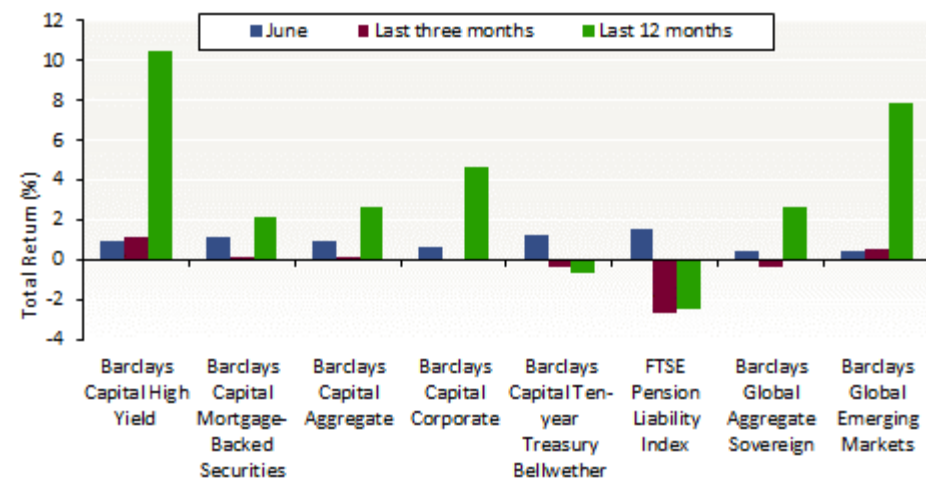

Equity Style Performance



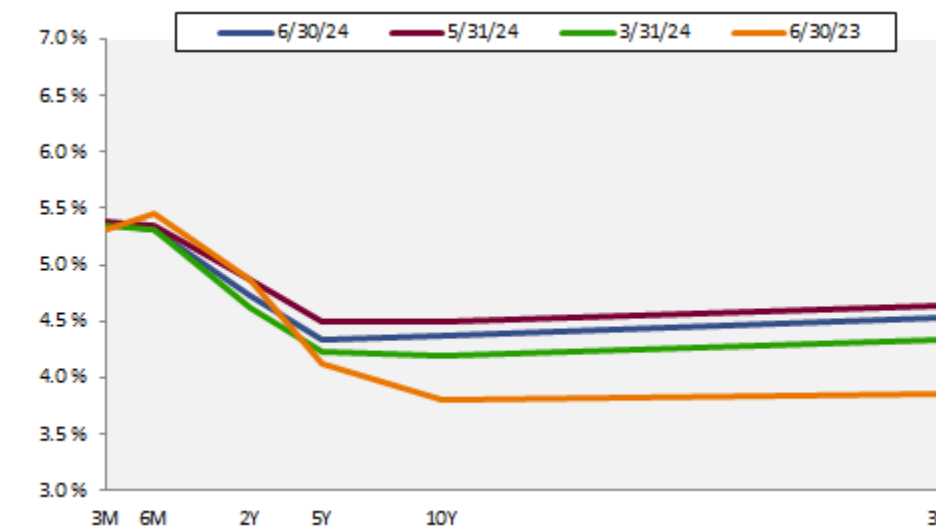

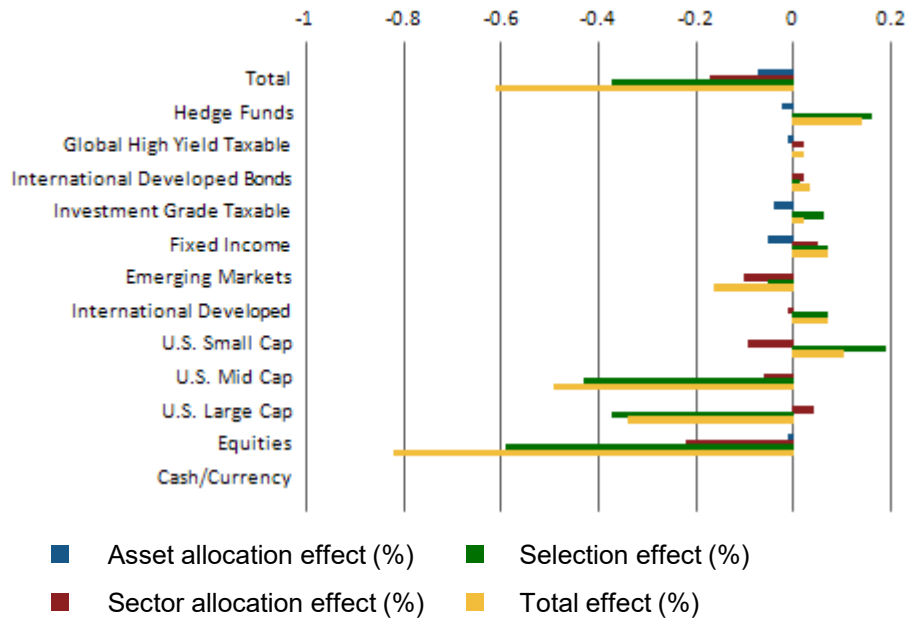

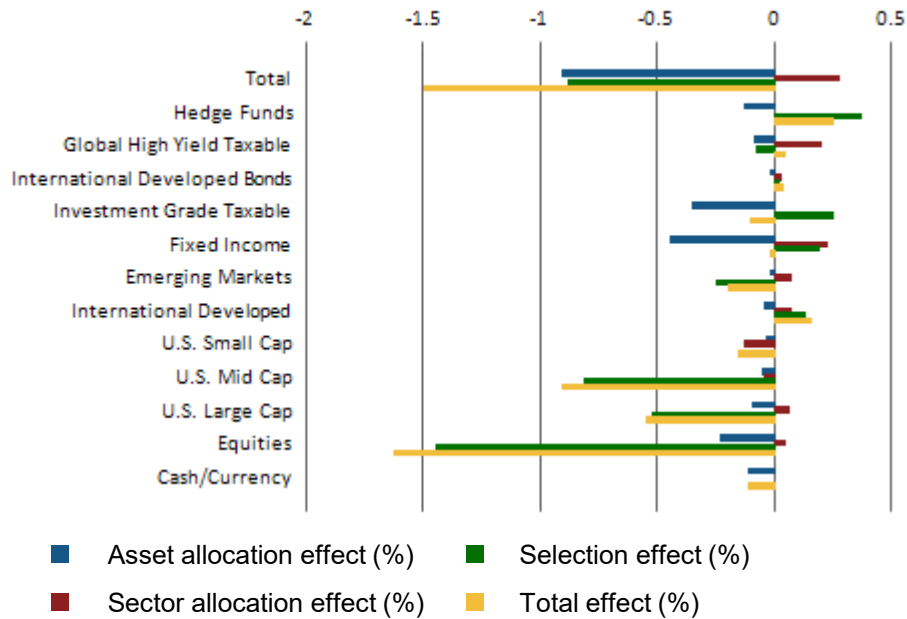

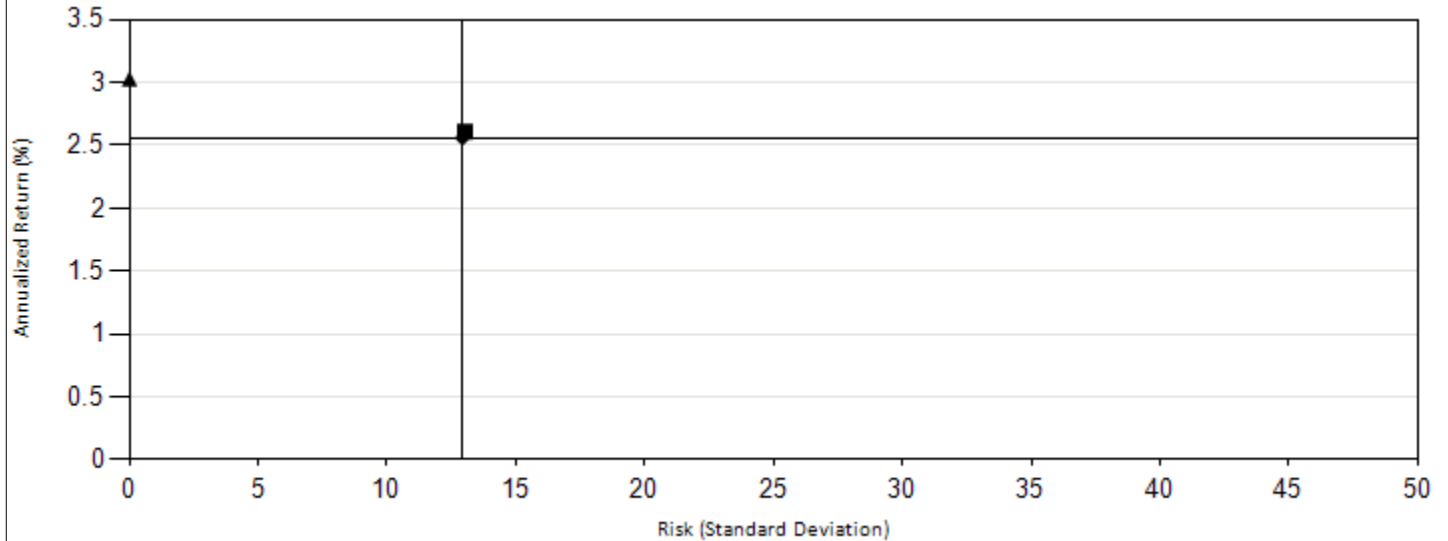

Standard Deviation – A gauge of volatility which measures the spread of the difference of returns from their average. The more a portfolio's returns vary from its average, the higher the standard deviation. It is important to note that higher than average returns affect the standard deviation just as lower than average returns. Thus, it is not a measure of downside risk. Since it measures total variation of return, standard deviation is a measure of total risk.

Beta – A relative measure of the risk level of a manager. Beta measures the systematic risk, or the return that is attributable to market movements. This measure is relative to the benchmark defined (i.e. Standard and Poor's 500, Russell 2000 Growth). A beta equal to one indicates a risk level equivalent to the benchmark defined. Higher betas are associated with higher risk levels, while lower betas are associated with lower risk levels.

Alpha – A measure of the difference between a portfolio's actual return and its expected performance, given its level of risk as measured by beta. A positive alpha figure indicates the portfolio has performed better than its beta would predict.

R-Squared – It is used to show how much a manager's variability can be accounted for by the market. For example, if a portfolio's R-squared is 0.79, then 79% of the manager's variability is due to market conditions. As R-squared approaches 100, the portfolio is more closely correlated with the market.

Sharpe Ratio – A ratio that measures risk-adjusted performance. The Sharpe Ratio is calculated by subtracting the risk-free rate – such as that of the 90-Day Treasury Bill – from the rate of return for a portfolio and dividing the result by the standard deviation of the portfolio returns.

Treynor Ratio – A risk-adjusted measure of return based on systematic risk. The ratio measures returns earned in excess of that which could have been earned on a riskless investment per each unit of market risk. It is similar to the Sharpe Ratio, with the difference being that the Treynor Ratio uses beta as the measurement of volatility.

Tracking Error – A divergence between the price behavior of a position or a portfolio and the price behavior of a benchmark.

Information Ratio – A ratio of portfolio returns above the returns of a benchmark (usually an index) to the volatility of those returns. The information ratio (IR) measures a portfolio manager's ability to generate excess returns relative to a benchmark, but also attempts to identify the consistency of the investor.

Standard and Poor's GSCI is a composite index of commodity sector returns representing an unleveraged, long-only investment in commodity futures that is broadly diversified across the spectrum of commodities. Constituents are selected by S&P Dow Jones Indices and must have an unadjusted market capitalization between \$400 million and \$1.8 billion to be considered for addition to the benchmark. 100% NCREIF Property Index is produced quarterly. The NCREIF Property Index (NPI) shows real estate performance returns using data submitted by its Data Contributing Members. The NPI is used as an industry benchmark to compare an investor's own returns against the industry average.
